## Visit of Commissioner Carlo Ripa di Meana to Berne, February 12, 1990

- Ripa di Meana (R) stayed only a few hours in Berne. He had a luncheon and a two hours talk with Federal Councillor Flavio Cotti (interior affairs including environment) and a short contact with Federal Councillor Adolf Ogi (transport, energy and communications).
- 2. On the European Environment Agency, R holds further delay likely. If no compromise is found between positions of Council and Parliament, the Commission may consider withdrawing its proposal. R repeatedly stated his support for a full and equal participation of EFTA countries in the Agency. This enlargement could be negotiated immediately after a final EC-decision is taken. EC ministers for environmental affairs will discuss this aspect at their informal meeting in Ireland at the end of April.
- 3. R considers likely that the EC-EFTA ministerial conferene will be held after the change of Presidency (Italy/Switzerland). He indicated the following points as likely items for the agenda:
  - environmental aspects of assistance to countries in Central and Eastern Europe,
  - participation of EFTA-countries in Environment Agency,
  - environmental aspects of ongoing EES negotiations,
  - specific items such as clean lorry.
- 4. Within the **Noordwijk process** the Commission plans to organize a seminar on biotechnology and testing.
- 5. R repeatedly stated including in his press conference that in the context of the current negotiations on a EES, the Community did not seek to oblige EFTA countries to lower their environmental standards.
- 6. Other items include:
  - R plans to propose creation of a European Environment Fund (in line with existing EC structural funds). The proposal should be ready by 1991 to be set up in 1992. It will be open to EFTA countries.
  - The Commission is working on a system of fiscal (dis)incentives in support of environmental objectives (Umwelt-Lenkungsabgaben).
  - R gave details on the Commission's work on the "clean and silent lorry".
