I send you herewith the correspondence re the above mentioned subject which is mostly self-speaking.

Regarding PDP I can give you the following additional informations:

After a coordinated action on March 9 (see letter) with FRG Embassy which wrote the same letter to the Ministry of Foreign Affairs, On March 27 I went with the Charge d' Affairs FRG to the Home Ministry, Additional Secretary Mr. Rajbhandari, to complain about the vehicles. On the next morning 28.4.90 they had been given back to the project with the threat to confiscate them again when needed.

This has been done:

Car 154 sequestered on 3.4. and not returned yet

Car 18 used by police on 2.4.

Car 17 taken by police on 2.4. and not been seen since then.

On March 27, 1990 when coming back from Chautara, District of Sindhupalchowk, I crossed the toyota pick-up Nr. 8006 moving up from Sangachowk to Chautara. It was 6 pm. approximately. The vehicle was occupied by 4 civilians in the cabin and some 12 policemen in uniform on the bridge.

The pick-up Nr. 8006 was handed over from IHDP to the District Panchayat Secretariate of Sindhupalchowk on Oct 4th 1988. As seen in the attached copy of the handing-over agreement, the Local Development Officer of Sindhupalchowk took the obligation to the With extensive interpretation, the transportation of police torce cannot be considered to fall in this category. It is therefore a clear violation of an existing agreement.

- 2. The Borrower of this vehicle will be liable to follow the lender's vehicle rules and regulations.
- The vehicle is explicitly for the implementation of IHDP Programmes of District Line Agencies.
- 4. District panchayat secretariat. Sindhupalchowk is responsible to coordinate the use of the vehicle for all the District Line Agencies which implement IHDP Programmes.
- 5. The Borrower is responsible for the fueling, maintanance and repair work. The necessary budget is with the District Panchayet Secretariate.
- 6. IHDP is providing a driver on deputation to the District Panchayat Secretariat. Sindhupalchowk. The necessary salary and allowances is in the budget of the District Panchayat Secretariat.
- 7. The Borrower has to channelize monthly vehicle Log Book to the Transport sector, DDP within the first week of the new month.
- 8. This rules will be valid till the period of a formal handing-



I. Communication about NPDP Datsun pick-up plate no 1461 BA.A.Jha

A. This short note is written under the request of SDC/N acting Director, Mr.R. Wieser. It will inform the reader about the NPDP car Datsun pick-up no.1461 BA.A.Jha.

B. This car was purchased by SDC for NPDP in 1980. On the 3th Of February 1981 the car was officially handed-over to HMG .

The Agreement between the Government of Switzerland and His Majesty's Government of Nepal concerning the Integrated Potato Development Project (IPDP), done in Kathmandu on the 9th of December 1977, and valid for 5 years, mentioned at page 3, article & . Thati. ". The Swing Coule 4 (hrr: ho specific reference is given for vehicles) to the Project on a CIF Kathmandu basis. The equipment financed by the Swiss Government shall be imported by SATA, upon arrival in Nepal be made available to the Project and thereby become the property of His Majesty's Government of Nepal".

The Agreement for the National Potato Development Programme (1983 - 1987) is more specific on the ownership matter. The article 13. "Ownership of Project equipment and Inspection" mentioned at the point 13.1: " Items purchased and/or imported by SATA shall become the property of HMG/N upon import and signature of a handing over note. However, the basic transportation means (e.g. vehicles, motorbikes) given through SATA shall become the property of HMG/N as and when the collaboration between the Swiss Government and HMG/N for the project ends. HMG/N shall put up an inventory for the above mentioned items, keep it up to date and control its conformity". It continues with point 13.2: " The items referred to under Article 13.1 shall be made available for the exclusive use of the Project". Point 13.3 can also be mentioned for its contingent relevance: " HMG/N shall enable the representative of the Swiss Government to inspect the items imported by SATA or financed out of the proceeds of the Swiss Contribution as well as any other relevant records and documents including all accounts of the Project".

In the present Agreement between the two Governments (1988 - 1992) the article 8, at page 8, under property of the programme mentions: " Items purchased out of funds made available by Switzerland will become the property of HMG/N upon arrival and transferal by means of a handing-over note. Items handed over will be kept at exclusive disposal of the programme's units, having requested the procurement, for their duration. HMG/N will cause proper records and inventories to be kept of all such items. Worn-out and otherwise unsuitable goods will be immediately auctioned or written off. Vehicles provided by SDC/N shall become the property of HMG/N as and when the collaboration between Switzerland and HMG/N for the programme ends.

TEL: 5-25513 5-22114 FAX: (9771) 525358 TELEX: 2245 SATA NP If operational circumstances prevail which make it expedient to transfer ownership of certain vehicles to HMG/N, SDC may do so even before cooperation for the project between SDC and HMG/N ends subject to common understanding between the two parties and signature of a handing-over note".

Now, if the first agreement (1977 - 1982) is binding - the car was purchased during this agreement - SDC does not seem to be in a strong position for an official claim. Only the two successive Agreements have a more detailed phrasing on property, and they give more space for strong reaction. It would be better to consult a legal advisor to sort out the matter before launching in strong protest.

- C. Until the 18th of January 1990 the car was used in NPDP. On that day it was given to the Bagmati Zone Zonal Office under request coming through the official HMG channel (from Zonal Office to Home Ministry, from Home Ministry to Ministry of Agriculture, from Ministry of Agriculture to NARSC (National Agriculture Research & Service Centre), and from NARSC in a written form to NPDP Chief (National Potato Development Programme)). The written request to NPDP is lost.
- D. During the last weeks the car was repeatedly seen loaded with persons of the security force, especially in the center of Patan.
- E. On the 2nd of March 90 a formal request written by Mr.W.Wirz,SDC/N Director to Mr.B.K.Bhomi,NPDP Chief (see copy in annex) received a prompt answer from Mr.B.K.Bhomi, but no action followed that exchange of letters.
- F. To the limit of the paradox, few days ago the zonal office in NPDP chief thought to mobilize the necessary funds through the Joint Account (SDC funds but administrated through HMG R&R: the signature of NPDP Chief and NPDP/SDC Co-manager is necessary to withdraw the funds from the bank), but obviously I did not accept to sign the bank draft.
- G. On the 30th of March at Gabahal of Lalitpur District the car was burnt by the people of Patan during the fight against the security force. The driver, Mr.Dev Lal Maharajan, HMG-NPDP driver, was quite badly injured during the incident.

The car relict is parked in front of the Police Office of Jawalakhel.

H. Historical note: The same car was used for at least 4 months during the 1983's elections. When the car came back to NPDP its body was quite badly damaged.
