In Folge der verschiedenen Vorschlaege und Gegenvorschlaege findet Ihr in der Beilage den schweizerischen Plan, der gleichzeitig den israelischen und iranischen Gespraechspartnern ausgehaendigt werden soll. In Fortsetzung unserer engen Zusammenarbeit in diesem Dossier ersuche ich Euch, den Plan noch NICHT Euren Gastlaendern zu unterbreiten, sondern uns Eure eigenen allfaelligen Kommentare und Anmerkungen bis Montag, 15. Juli 1991 zukommen zu lassen. In der Folge werden wir Euch den definitiven, zu ueberreichenden schweizerischen Vorschlag zustellen.

Quote Comprehensive Swiss proposal

This plan is based solely on humanitarian considerations and should complete the humanitarian process which Switzerland has started and worked on for more than one year. Stage one and two are integral parts of one single plan which has to be carried out in its entirety.

First stage (Confidence building measures)

1. - Liberation of 108 persons captured in Lebanon, actually detained in Khiam or Israel, according to a list established by Israel
- Liberation of two sick American hostages, Alan Steen and Terry Anderson, and one British hostage, chosen by the

groups in Lebanon

2. Exchange of the following dead bodies

- Josef Fink, IDF soldier
  - Rahamim Levi Alsheikh, IDF soldier
  - Colonel William Higgins, US-citizen
  - William Buckley, US-citizen
- (All 4 are previously to be identified by a Swiss doctor)

-All the remains of members of the Lebanese groups, buried in Israel and/or the security zone

3. The first stage has to be fully accomplished within 4 weeks after the present plan has been accepted by all parties concerned. The exchange will take place either in South Lebanon or Damaskus.

4. The operation will be carried out under Swiss supervision, organisation and responsibility.

Second stage

5. a) A sign of life or proof of existence of Mr. Ron Arad has to be presented by any source knowing his whereabouts.  
b) ICRC-representatives are allowed to visit Sheikh Abed el Karim Obeid.

Stage two should be accomplished within 4 weeks after the end of stage one.

Third stage

6. All involved parties commit themselves to the continuation of the operation until the release or exchange of all localized and not yet localized prisoners or hostages, unlawfully interned, within short time.

This plan takes into account proposals submitted by different parties involved. Fast progress in this issue is expected.
