To: Neutral Nations Supervisory Commission

I present my compliments to the Neutral Nations Supervisory Commission and send this letter in connection with the extremely grave criminal act which the United Nations Command side has been committing by introducing nuclear weapons into south Korea to turn it further into a nuclear attack base, creating a danger of nuclear war in Korea in flagrant violation of the Armistice Agreement.

Recently, a retired Rear Admiral Gene R. LaRocque, former captain of the U.S. 7th Fleet's flagship, exposed at a congressional joint committee on atomic energy that "U.S. warships do not unload their nuclear weapons before entering foreign ports" and that "...American nuclear warheads and nuclear bombs are kept in igloo-shaped, concrete storehouses" in south Korea (Washington, A.P., October 6, 1974).

In addition, the U.S. imperialists committed the criminal act of again illegally bringing the attack carrier "Midway" carrying nuclear weapons to the Port of Pusan in south Korea on October 4, which had been there in April last, (south Korean "Radio Pusan," October 4, 1974). Besides, the U.S. imperialists have been successively conducting in the front areas near the Demilitarized Zone exercises of firing guided missiles which were introduced in violation of the Armistice Agreement.

On September 19, the U.S. imperialist aggressors mobilized the 4th Missile Command and A Battery, 1st Battalion, 42nd Artillery of the U.S. imperialist aggression forces occupying south Korea to the vicinity of **Sayo-ri** about **4.5 kilometers** south of the Demilitarized Zone in the central part of the front, which fired several "Honest John" rockets (Stars and Stripes," September 21, 1974) and not long ago, committed a provocative act of "airlifting" the entire battery

of the "Nike Hercules" guided missile to the vicinity of the Demilitarized Zone ("Stars and Stripes," October 1, 1974).

Indeed, all these acts cannot be construed otherwise than a flagrant violation and disruption of the Preamble of the Armistice Agreement and Sub-paragraph 13d thereof, a criminal act of gravely jeopardizing peace in Korea and the world and an intolerable challenge to the Korean people and the peace-loving peoples the world over who are desiring peace in Korea and her peaceful reunification.

The entire Korean people and men and officers of the Korean People's Army resolutely denounce the U.S. imperialist aggressors for their having been turning south Korea further into a nuclear attack base and creating a danger of nuclear war in our country, taking it seriously.

We cannot but direct a due attention to the fact that the U.S. imperialist aggressors have been turning south Korea further into a base for nuclear weapons and guided missiles today when the peoples all over the world are raising higher their voices as days go by in demand of the withdrawal of the U.S. imperialist aggression troops wearing the cap of the "U.N. Forces" from south Korea.

In order to remove the tense situation created in Korea today and to turn the armistice into a durable peace, an immediate and unconditional end must be put to the criminal manoeuvres of the U.S. imperialist aggressors turning south Korea into a nuclear attack base and the U.S. imperialist aggression forces should take off the helmet of the "U.N. Forces" and immediately withdraw from south Korea taking along with them all the illegally introduced mass destruction weapons.

I hope that your Commission with the mission of supervising the implementation of the Korean Armistice Agreement will seriously discuss the criminal acts of the United Nations Command side which has been turning south Korea further into a nuclear attack base and is
