Monsieur le Conseiller fédéral,

Pour faire suite à ma lettre du 3 février, j'ai l'honneur de porter à votre connaissance que le Secrétaire d'Etat vient de communiquer à la presse, en date du 4 mars, sa décision relative au statut de M. John Carter V i n c e n t , ancien Ministre des Etats-Unis à Berne.

Aux termes du texte officiel, que vous voudrez bien trouver ci-joint, M. Vincent a été admis à faire valoir ses droits à la retraite à partir du 31 mars 1953, ce qui le mettra au bénéfice d'une pension annuelle d'environ \$8.100.

Dans sa déclaration, M. Dulles commence par rappeler les circonstances à la suite desquelles il avait été saisi de l'affaire. Après avoir étudié personnellement le dossier, comme il avait promis de le faire, il est arrivé à la conclusion que M. Vincent ne devait pas être maintenu dans les cadres du service diplomatique. Bien que le Secrétaire d'Etat ne soit pas tenu d'indiquer les motifs de sa décision, il a jugé bon de donner les précisions suivantes dans une affaire où l'intérêt public est engagé :

- 16 il n'estime pas que M. Vincent soit un "risque" en ce qui concerne la sécurité du pays;
- 26 il ne considère pas qu'il y ait des raisons de douter du loyalisme de M. Vincent à l'égard du gouvernement américain;
- 36 il est toutefois arrivé à la conclusion que les rapports de M. Vincent, son évaluation des faits et la politique qu'il a conseillée pendant la période en question, n'étaient pas à la hauteur de ce qui est exigé d'un diplomate de son expérience à l'époque critique où nous vivons.

L'ancien Ministre des Etats-Unis à Berne se voit donc lavé de l'opprobre dont l'avait couvert le Comité de révision pour les questions de loyalisme de l'ancienne administration, lorsque celui-ci avait conclu à l'existence d'un doute raisonnable quant à son loyalisme. Mais en même temps, il reçoit, en arrivant au terme de sa carrière, un blâme sérieux. C'est donc une cote mal taillée, une solution de compromis, qui d'une part donnera une certaine satisfaction aux critiques de la politique américaine d'après guerre en Chine et, de l'autre, apaisera quelque peu ceux qu'indignait l'injustice faite à M. Vincent.

La décision du Secrétaire d'Etat est moins défavorable à celui-ci qu'on aurait pu le craindre. Mais en laissant apparaître qu'elle a été inspirée par des considérations d'ordre politique, elle ne dissippera pas tout le malaise. Le Washington Post estime que l'affaire a été réglée de la façon aussi satisfaisante que le permettaient l'hystérie - allusion au mccarthysme - et l'esprit de parti prévalant ici. Et c'est sans doute ce qu'il faut se dire. Mais les jeunes diplomates au service du Département d'Etat n'y trouveront pas un encouragement à éclairer sincèrement et honnêtement l'opinion de leur gouvernement.

Text of Dulles Statement Retiring Vincent

WASHINGTON, March 4 (A)-Following is the text of a state-ment by Secretary of State John Foster Dulles announcing he had retired John Carter Vincent, State Department career officer:

I. Background

Among the inheritances which the present Administrator took over from the past Administration is the so-called "Vincent

John Carter Vincent, a Foreign Service officer, with the rank of Career Minister (the highest rank), has since 1951 been the subject of inquiry and controversy because of his conduct in

versy because of his conduct in relation to China and Japan, particularly during the war and postwar period (1941-1947).

Charges of disloyalty against Mr. Vincent, made in November, 1951, were heard by the Department of State Loyalty Security Board. It unanimously decided that no reasonable doubt existed. that no reasonable doubt existed as to Mr. Vincent's loyalty to the Government of the United States and that his continued employment did not constitute a risk to the Department of State.

This decision was twice reconsidered by the department's boards to take account of new evidence. In each case the original decision was confirmed.


When, however, the matter was reviewed by the Civil Service Loyalty Review Board, it found, by a 3-2 decision rendered Dec. 22, 1952, that there was reasonable doubt as to Mr. Vincent's loyalty to the Government of the United States. Accordingly, the board recommended that his services should be terminated.

This conclusion of the Loyalty

This conclusion of the Loyalty Review Board was merely advisory to the Secretary of State. The then secretary [Dean Acheson] set up a special panel to examine the matter again and ad-vise him as to what disposition they thought should be made of

After I became Secretary of State, I received an inquiry on behalf of the members of the special panel as to whether I special panel as to whether I wished them to continue to study the case under the mandate they had received from my predecessor in office. In reply I said that I felt it unnecessary for them to continue their advisory study. placed the ultimate responsibility on me and I saw no way to shed that responsibility.

Since then, I have carefully studied the record with a view to discharging my legal responsibility in a way which will both

protect the interests of the United States and do personal justice.

II. Jurisdiction

My jurisdiction in this case stems from three sources:

1. I have authority to terminate

Mr. Vincent's services on "security" grounds (Public Law 733, Eighty-first Congress, Aug. 26,

2. I have authority to terminate Mr. Vincent's services on "loyal-ty" grounds (Executive Order No. 9835, March 21, 1927, as amended by Executive Order No. 10241, April 28, 1951).

3. I have authority in my "abso-3. I have authority in my "absolute discretion" to terminate Mr. Vincent's services if I deem this "necessary or advisable in the interest of the United States" (Public Law 495, Eighty-second Congress, July 10, 1952).

III. The Facts

Mr. Vincent served in China almost continuously from 1924 to 1936 in consular capacities or as a Chinese language officer. From 1936 to 1947, except for a short interruption, he served in key positions in China and in Washington in relation to Chinese, Japanese and Far Eastern matters. ters.

During this later period he was

largely relied upon by his superiors, notably the President, the Secretary of State and George [George C.] Marshall when he headed a special Presidential mission to China in 1945 and 1946.

M. Vincent's part in these matters and his associtaions during this time are brought out in detail in the records which I have examined. They have led me to conclude that Mr. Vincent's employment as a foreign service officer should not be continued.

IV. Reasons

Under Public Law 495 I am not required to give reason for my decisions under that law. They are a matter of "absolute discretion." However, in view of the public interest which attaches to this case, I feel that I should state:
1. I do not believe the record

shows that Mr. Vincent is a "se-curity" risk within the usually accepted meaning of that term and within the meaning which up to now has customarily been given to that term in Public Law

733.

2. I do not find that "on all the reasonablet evidence, there is reasonablet doubt as to the loyalty" of Mr. Vincent to the Government of the

Vincent to the Government of the United States within the meaning of Executive Order 10241.

3. I have, however, concluded that Mr. Vincent's reporting of the facts, evaluation of the facts, and policy advice during the period under review show a failure to meet the standard which is demanded of a Foreign Service of his evaporisacts and recommended. officer of his experience and responsibility at this critical time. I do not believe that he can usefully continue to serve the United States as a Foreign Service of-

Public Law 495 recognizes the special responsibilities which, at this time of dangerous international tensions, devolve on the Secretary of State and reflects an intent that he should act to safe-guard what he, in his discretion, deems the interests of the United States. I believe that that legislative purpose is sound and I am responding to it according to my best judgment.

V. Conclusion

While this memorandum was in course of preparation, I talked with Mr. Vincent and told him generally of my views. Subsequently, Mr. Vincent submitted his resignation as Minister to Morocco and Diplomatic Agent at Tangier and placed in my hands his application for retirement. I am granting his application for retirement effective March 31,
