Swiss Bankers Prepaid Services Ltd: New Management Appointments

Simone Fischer and Sascha Breite have joined the management



Grosshöchstetten / Zurich, 3 August 2018 – A little more than a year ago, Swiss prepaid card issuer Swiss Bankers Prepaid Services Ltd decided on a number of strategy adjustments intended to prepare the company for changes in the rapidly evolving payment solution environment.

In order to meet the necessary organizational and personnel requirements, the Board of Directors adopted the following changes regarding the organization of Swiss Bankers at its meeting of 21 June 2018. As per 1 August 2018, the CMO area was divided into two management areas.

- The newly created **COO** area is headed by Ms. Simone Fischer. She joined the management on 1 August 2018 and is responsible for Customer Service, Distribution, Back Office and Fraud Prevention as well as the Money Send division. Ms. Fischer and her teams will work in Grosshöchstetten as before.
- The CMO area, which includes Marketing, Product Management, Sales, and now also the Business Development division, is headed by Mr. Sascha Breite. He also joined the Swiss Bankers management as per 1 August 2018, and he and his teams will operate from the Zurich location.

Mr. Stephan Lindecker, who previously held the COO and CMO positions, left the management and the company on 1 August 2018 following the strategy realignment.
